



ATTENTION PARENTS

DID YOU KNOW... The Tennessee Department of Health has issued new immunization requirements effective July 1, 2010 for children enrolling in Pre-school, Kindergarten, Seventh grade or as a new student entering Tennessee Schools. Please note, a new Immunization Certificate will be required for these children to enroll documenting that they have received these vaccines. The new immunization requirements are underlined:

Pre-School requirements:

- Diphtheria-Tetanus-Pertussis (DTaP or DT)
- Hepatitis A
- Hepatitis B (HBV)
- H.influenzae (HIB)
- Measles, Mumps, Rubella (MMR)
- Pneumococcal (PCV)
- Poliomyelitis (IPV or OPV)
- Varicella (Chickenpox)

Seventh (7th) grade requirements:

- Tetanus-diphtheria-pertussis booster (Tdap)
- Varicella (Chickenpox) - 2 doses or history of disease

Kindergarten requirements:

- Diphtheria-Tetanus-Pertussis (DTaP or DT)
- Hepatitis B (HBV)
- Measles, Mumps, Rubella (MMR) - 2 doses
- Polio (IPV or OPV): final dose on or after 4th birthday
- Varicella (Chickenpox): 2 doses or history of disease

New enrollees in a Tennessee school other than Kindergarten or 7th grade:

- Diphtheria-Tetanus-Pertussis (DTaP or DT)
- Hepatitis B (HBV)
- Measles, Mumps, Rubella (MMR) - 2 doses
- Polio (IPV or OPV): final dose on or after 4th birthday
- Varicella (Chickenpox): 2 doses or history of disease

Beat the rush! Contact your child’s doctor or the Chattanooga-Hamilton County Health Department to make sure your child is fully vaccinated. ***Vaccinations are available on a walk in basis at the following health department clinics:***
