SNAPSHOT OF MORTALITY

Five Leading Causes of Death in Hamilton County, 2004-06:

1. Heart Disease
2. Cancer
3. Chronic Lower Respiratory Disease
4. Stroke
5. Alzheimer's Disease

Changes in Rates (2001-03 to 2004-06):

- Heart disease (down 8%)
- Stroke (down 12%)
- Accidents (up 18%)
- Diabetes (down 14%)
- Alzheimer's Disease (up 54%)
- Influenza and Pneumonia (down 22%)

Focus areas for improving the health of our community:

- Nutrition and physical activity
- Tobacco cessation
- Alcohol abuse cessation
- Hygiene and hand-washing

Changes & Trends in Hamilton County:

- Obesity and overweight trends are on a steady rise, from 41% in 1999 to 60.8% in 2007.
- Cigarette smoking has decreased from 27% in 1999 to 22.6% in 2007.
- The percent of low birth-weight infants (less 2500 grams) has increased from 7.9% in 1990 to 12% in 2007.
